- Applying organization must provide evidence of solvency and good standing, and must comply with applicable government laws, rules, and regulations as they pertain to J-1 Cultural Exchange programs
- All communication representing the ACEO to any non-ACEO organizations (e.g. "the public") must be approved in writing by the ACEO board prior to dissemination (e.g. letters to ECA, government officials, policy/position statements, etc.)
- Approval for affiliation by ACEO Board
